RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK dated October 19, 2021 by Bank of America, N.A., a national banking association, with its mailing address at 25 Burlington Mall Road, Suite 205, Burlington, Massachusetts 01803 (“*Lender*”);

WITNESSETH:

WHEREAS, Little Leaf Farms, LLC, a Delaware limited liability company (“*Borrower*”), with its mailing address at 84 Shady Brook Lane, Carlisle, Massachusetts 01741-1867 and Lender were parties to a certain Trademark Collateral Agreement dated May 31, 2019 between Borrower and Lender which was recorded in the United States Patent and Trademark Office on May 31, 2019 at Reel 006658, Frame 0387 (the “*Agreement*”), pursuant to which Borrower granted to Lender, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”). - (a) all of Borrower’s registered and unregistered trademarks, trademark applications, service marks, trade names, trade styles, logos, goodwill and rights in trademark applications, trademarks, service marks, trade names, trade styles, logos, goodwill owned by others (collectively the “*Trademarks*”) which in the case of trademarks or trademark applications, are now or hereafter issued by or filed with the U.S. Patent and Trademark Office or any similar office or agency of any other countries, including without limitation the trademarks and trademark applications listed in Schedule A attached hereto and made a part hereof;
- (b) all Intellectual Property that is related to the Trademark Collateral; and
- (c) all proceeds of all of the foregoing (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements of the Trademarks, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.
