**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** dated as of October 20, 2021 (this “Release”) is made by **CAPITAL SOUTHWEST CORPORATION**, as administrative agent (together with its successors and assigns, in such capacity, the “Administrative Agent”), under that certain Intellectual Property Security Agreement dated as of September 16, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”) by and between **SONOBI, INC.**, a Delaware corporation (“Grantor”) and the Administrative Agent for itself and the other Secured Parties, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 7055, Frame 0739. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the IP Security Agreement.

Pursuant to the IP Security Agreement, Grantor granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest (“Security Interest”) in Grantor’s right, title and interest of every kind and nature in the IP Collateral listed on Schedule I attached hereto.


The Administrative Agent now wishes to release and terminate all right, title and interest in the Trademark Collateral under the IP Security Agreement.
