TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") dated as of October 15, 2021 is made by PNC Bank, National Association, in its capacity as collateral agent for itself and the other Lenders pursuant to the Credit Agreement (as defined below) and as the Grantee (as defined in the Trademark Security Agreement (as defined below)) (together with its successors and assigns in such capacities, the "Agent") and Theragenics Corporation, Needletch Products, Inc., Galt Medical Corp., and C.P. Medical Corporation (each herein referred to as a "Grantor" and, collectively, the "Grantors");

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of January 25, 2016 by the Grantors in favor of the Agent (the "Trademark Security Agreement"), (ii) that certain second Trademark Security Agreement, dated as of June 20, 2019 by Theragenics Corporation and Galt Medical Corp. in favor of the Agent (the "Second Trademark Security Agreement") and (iii) that certain Third Amended and Restated Revolving Credit, Term Loan and Security Agreement, dated as of December 23, 2015 (as amended, extended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among, inter alios, the Grantors, the Agent and the Lenders, a lien on and security interest in all right, title and interest in and to any and all of each of the Grantor's rights (the "Interests") in certain collateral then owned or thereafter acquired by such Grantor, including the Trademark Collateral (as hereinafter defined), was granted by each Grantor to the Agent;

WHEREAS, capitalized terms used and not otherwise defined herein shall have the meaning specified in the Credit Agreement, Trademark Security Agreement or Second Trademark Security Agreement, as the case may be;

WHEREAS, pursuant to the Credit Agreement each Grantor granted to Agent a continuing security interest in all of such Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether then presently existing or thereafter arising or acquired:

- (i) each United States or foreign trademark, service mark and trade name then held or thereafter acquired by such Grantor, including any registration or application for registration of any trademarks and service marks then held or thereafter acquired by such Grantor, which are registered in the United States Patent and Trademark Office or the equivalent thereof in any State of the United States or in any foreign country, as well as any unregistered marks used by such Grantor, and any trade dress including logos, designs, company names, business names, fictitious business names and other business identifiers used by such Grantor in the United States or any foreign country (collectively, the "Marks"), including, without limitation, each Mark referred to in **Schedule I** annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Mark; and
- (ii) all products and proceeds of the foregoing, including, without limitation, all products and proceeds of any claim by such Grantor against third parties for past, present or future infringement or dilution of any Mark including, without limitation, any Mark referred to in **Schedule I** annexed hereto, or for injury to the goodwill associated with any Mark.

WHEREAS, certain Interests in the Trademark Collateral were recorded in the United States Patent and Trademark Office on February 4, 2016 in Reel 5724, Frame 0505 and certain Interests in the Trademark Collateral were recorded in the United States Patent and Trademark Office on July 4, 2019 in Reel 6686/0796; and

WHEREAS, the Agent desires to terminate and release the Interests in the Trademark Collateral and to reconvey any and all rights in the Trademark Collateral to the Grantors;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in accordance with the terms and obligations set forth in the Credit Agreement, the Agent hereby releases and discharges continuing security interest in all of Grantors' right, title and interest in, to and under the Trademark Collateral granted to the Agent by Grantors.
