The rights and remedies of the Collateral Agent with respect to the security interest granted herein are as set forth in the Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interest are deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall govern.


