**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of October 28, 2021, by **SILICON VALLEY BANK**, a California corporation (“**Bank**”), in favor of **FIELDWARE US, INC.**, a Delaware corporation (the “**Grantor**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of June 26, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Agreement**”), granting to Bank a security interest in all of its right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, the Trademarks (as each such term is defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (the “**USPTO**”) on June 30, 2014, at Reel 005311, Frame 0872.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Intellectual Property Collateral as herein provided; and

WHEREAS, Grantor has requested that Bank provide a document suitable for recording with the USPTO to evidence the release of Bank’s security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in Grantor’s right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, those Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY AND THEREBY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE UNITED STATES AND THE STATE OF CALIFORNIA, WITHOUT GIVING EFFECT TO ANY CHOICE OR CONFLICT OF LAW PROVISION OR RULE (WHETHER OF THE STATE OF CALIFORNIA OR ANY OTHER JURISDICTION).
