**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of November 5, 2021 (this “Release”) is made by Cadence Bank, N.A., as administrative agent (together with its successors in such capacity, the “Administrative Agent”), under that certain Trademark Security Agreement dated as of May 17, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) by and between American Equipment Systems LLC, a Delaware limited liability company (the “Grantor”) and the Administrative Agent for the Lenders, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 7315, Frame 0717. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.

Pursuant to the Trademark Security Agreement, Grantor granted to the Administrative Agent a security interest (“Security Interest”) in Grantor’s right, title and interest of every kind and nature in the Trademark Collateral listed on Schedule I attached hereto.


The Administrative Agent, now wishes to release and terminate, on behalf of itself and its successors, legal representatives and assigns, any and all right, title and interest in, to and under the Trademark Collateral under the Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby unconditionally and expressly releases, terminates, discharges and extinguishes, without any reservation, and reassigns to Grantor all right, title and interest in, to and under the Trademark Security Agreement in the Trademark Collateral, including any and all security interests, liens, pledges, charges and other encumbrances of any kind thereon.
