**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of November 9, 2021, by GOLDMAN SACHS BANK USA, as administrative agent for the Lenders and the other Secured Parties (in such capacity, together with its successors and permitted assigns, the “**Administrative Agent**”), in favor of PERIMETER SOLUTIONS LP (F/K/A ICL PERFORMANCE PRODUCTS LP) and PHOSPHORUS DERIVATIVES INC. (together, the “**Grantors**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantors and the Administrative Agent are party to (i) that certain Second Lien Security Agreement dated as of March 28, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and (ii) that certain Trademark Security Agreement, dated as of March 28, 2018 (the “**Trademark Security Agreement**”), whereby the Grantors granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in and Lien on all of the Grantors’ rights, titles and interests in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those United States Trademarks listed on Schedule I attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 20, 2018 at Reel/Frame 006359/0426; and

WHEREAS, the Grantors have requested that the Administrative Agent execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without any representation, warranty or recourse of any kind or nature, hereby terminates the Trademark Security Agreement and releases, discharges and terminates its security interest in and Lien on the Trademark Collateral, and re-assigns and re-conveys to the Grantors (as applicable) any and all right, title or interest the Administrative Agent may have in, to or under the Trademark Collateral. This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
