**AMENDED AND RESTATED TERM LOAN
GRANT OF SECURITY INTEREST IN TRADEMARKS**

THIS AMENDED AND RESTATED TERM LOAN GRANT OF SECURITY INTEREST IN TRADEMARKS (“Agreement”), effective as of November 18, 2021, is made by Gulf Oil Limited Partnership, a Delaware limited partnership (the “Grantor”), in favor of Morgan Stanley Senior Funding, Inc., as collateral agent (the “Agent”) for the Secured Parties (as defined in the Pledge and Security Agreement described below).

W I T N E S S E T H

Reference is made to (i) that certain Amended and Restated Credit Agreement (as amended, restated, supplemented or otherwise modified from time to time, the “Amended and Restated Term Credit Agreement”), dated as of November 18, 2021, by and among Gulf Finance Holdings, LLC, a Delaware limited liability company (the “Parent”), Gulf Finance, LLC, a Delaware limited liability company (the “Borrower”), the Agent and the lenders from time to time party thereto (the “Lenders”) and (ii) that certain Amended and Restated Pledge and Security Agreement, dated as of November 18, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”), by and among the Parent, the Borrower, the other Grantors from time to time party thereto and the Agent.

Reference is also made to that certain Term Loan Grant of Security Interest in Trademarks, dated as of August 25, 2016, entered into by the Grantor and the Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Original Trademark Security Agreement”).

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantor has pledged and granted to the Agent for the ratable benefit of the Secured Parties a continuing security interest in its Intellectual Property included in the Collateral, including the Trademarks (as defined below) included in the Collateral;

WHEREAS, on the date hereof, the Grantor and the Agent have agreed to amend and restate the Original Trademark Security Agreement on the terms and conditions set forth herein;

WHEREAS, it is the intent of the parties hereto that this Agreement not constitute a novation, release or termination of the obligations under the Original Trademark Security Agreement, but that this Agreement amend and restate the Original Trademark Security Agreement and the Grantor wishes to affirm its obligations under the Original Trademark Security Agreement;

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to enter into and extend credit to the Borrower under the Amended and Restated Term Credit Agreement, the Grantor agrees, for the benefit of the Agent and the Secured Parties, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Pledge and Security Agreement or, if not defined therein, in the Amended and Restated Term Credit Agreement.

SECTION 2. Grant of Security Interest. The Grantor hereby pledges, assigns, hypothecates and grants to the Agent, for the benefit of the Secured Parties, a security interest in and a Lien on all of the

Grantor's right, title and interest in and to all of its property and assets, including, but not limited to, all trademarks, service marks, domain names, trade dress, logos, designs, slogans, trade names, business names, corporate names and other source identifiers (including, without limitation, those items listed on Schedule A hereto), whether registered or unregistered, together, in each case, with the goodwill symbolized thereby, wherever located, whether now owned or in the future acquired by the Grantor and whether now existing or in the future coming into existence (collectively, the "Trademarks"); provided that, the Trademarks shall not include any United States intent-to-use trademark application to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark application under applicable federal law.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Agent in connection with the Pledge and Security Agreement and is expressly subject to the terms and conditions thereof. The Pledge and Security Agreement (and all rights and remedies of the Agent thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the security interest in the Trademarks granted hereby are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. Delivery of an executed signature page of this Agreement by facsimile transmission or by electronic mail as a ".pdf" or ".tif" attachment shall be effective as delivery of a manually executed counterpart hereof.

SECTION 6. Governing Law. This Agreement and the rights and obligations of the parties under this Agreement shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.

SECTION 7. Reaffirmation. The Grantor reaffirms the security interest granted under the terms and conditions of the Original Trademark Security Agreement and agrees that such security interest remains in full force and effect and is hereby ratified, reaffirmed and confirmed. The Grantor acknowledges and agrees with the Agent that the Original Trademark Security Agreement is amended and restated pursuant to the terms hereof.


