**First Lien Release of Security Interest in Trademarks**

This First Lien Release of Security Interest in Trademarks, dated as of November 18, 2021 (the “Release”), is made by UBS AG, STAMFORD BRANCH, as collateral agent (in such capacity, the “Agent”) in favor of SIMPSON PERFORMANCE PRODUCTS, INC., DRAKE AUTOMOTIVE GROUP, LLC and PROFORGED, LLC (each, a “Grantor” and collectively, the “Grantors”).

WHEREAS, by (i) that certain First Lien Security Agreement, dated as of October 26, 2018 in favor of Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related first lien Grant of Security Interest in Trademark Rights, dated as of January 8, 2021 in favor of Agent (as amended, restated, or modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), the Grantors granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantors’ right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantors desire Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantors (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral of the Grantors (as defined in the Trademark Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantors any and all of its rights, title and interests in the Collateral.

The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.


The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.






