And ASSIGNOR does further covenant and agree that it will, at any time upon request, communicate to ASSIGNEE, its successors, assigns or other legal representatives, such facts relating to said trademarks and registrations or the file histories thereof as may be known to it, and testify as to the same in any litigation or other related proceeding when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

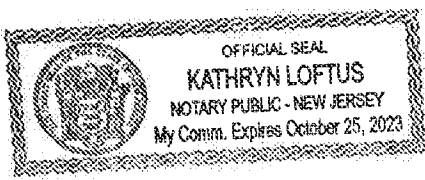
