**TERMINATION OF SHORT FORM  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION OF SHORT FORM INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “**Termination**”) as of December 1, 2021, by WILMINGTON SAVINGS FUND SOCIETY, FSB, as trustee and collateral trustee (the “**Trustee**”) in favor of LATIN LOGISTICS, LLC, a Florida limited liability company (“**Latin Logistics**”), AEROVÍAS DEL CONTINENTE AMERICANO S.A. AVIANCA, a corporation organized under the laws of the Republic of Colombia (“**Aerovias**”), INTERNATIONAL TRADE MARKS AGENCY INC., a corporation incorporated and existing under the laws of the Republic of Panama (“**International Trade Marks**”) and TAMPA CARGO S.A.S (“**Tampa Cargo**”) and together with Latin Logistics, Aerovias, and International Trade Marks, the “**Grantors**”).

**RECITALS**

WHEREAS, the Grantors and the Trustee are parties to that certain U.S. Intellectual Property Security Agreement, dated as of October 13, 2020 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “**IP Security Agreement**”);

WHEREAS, pursuant to the IP Security Agreement, each Grantor granted to the Trustee a security interest in all of such Grantor’s right, title and interest in and to the worldwide registered trademarks and trademarks for which worldwide applications are pending set forth in **Schedule A** hereto (collectively, the “**Release Collateral**”); and

WHEREAS, the Trustee wishes to terminate and release all security interests, pledges, assignments, mortgages and liens of record granted to it in the Release Collateral under the IP Security Agreement.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Trustee hereby releases, relinquishes and discharges, with respect to each Grantor, all of its lien on and security interest in and to all of such Grantor’s right, title, and interest in, to and under the Release Collateral.

The Trustee hereby authorizes the Grantor, or the Grantor’s authorized representatives to record this Termination with the applicable intellectual property offices worldwide, such as, e.g., the United States Patent and Trademark Office. The Trustee authorizes and requests that the applicable intellectual property office record this Termination.

This Termination may be signed in counterparts (which may include counterparts delivered by any standard form of telecommunication or electronic mail), each of which shall be an original and all of which together shall constitute one and the same instrument. This Termination shall be governed by, and construed in accordance with, the internal laws of the State of New York and the applicable laws of the United States of America.


