OF

The undersigned natural person, having capacity to contract and acting as the organizer of Helton Management Group, LLC, a limited liability company created in accordance with the Tennessee Revised Limited Liability Company Act, hereby adopts the following Articles of Organization for such limited liability company (the "Company"):


5. The Company shall be manager-managed.

8. The Company shall have a written operating agreement set out in a single integrated document which may be amended from time to time (the "Operating Agreement"). The Company shall not have oral operating agreements. The Company's Operating Agreement shall be binding upon a person who thereafter becomes a member or holder without the necessity of the person executing the Operating Agreement if the new member or holder otherwise complies with the conditions for becoming a member or holder as set forth in the Operating Agreement.

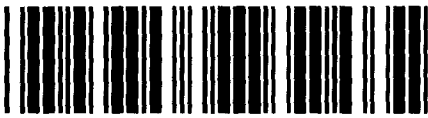
