**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 23, 2021 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as collateral agent (the “Agent”), in favor of the grantor parties identified on Schedule A (each a “Grantor,” and collectively, the “Grantors”). WHEREAS, pursuant to the Pledge and Security Agreement, Lacuna Health, LLC, as Grantor, executed and delivered a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018 (the “Lacuna Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office, pursuant to which such Grantor confirmed its grant of a security interest to the Agent in the Trademark Collateral of such Grantor;

WHEREAS, the Lacuna Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 5, 2018 at Reel/Frame 6372/0365;

WHEREAS, pursuant to the Pledge and Security Agreement, Kindred Healthcare, LLC, as Grantor, executed and delivered a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018 (the “Kindred Healthcare Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office, pursuant to which such Grantor confirmed its grant of a security interest to the Agent in the Trademark Collateral of such Grantor;

WHEREAS, the Kindred Healthcare Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 5, 2018 at Reel/Frame 6372/0350;

WHEREAS, pursuant to the Pledge and Security Agreement, Centerre Healthcare, LLC, as Grantor, executed and delivered a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018 (the “Centerre Trademark Security Agreement” and, together with the Lacuna Trademark Security Agreement and the Kindred Healthcare Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office, pursuant to which such Grantor confirmed its grant of a security interest to the Agent in the Trademark Collateral of such Grantor;

WHEREAS, the Centerre Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 5, 2018 at Reel/Frame 6372/0331;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, without representation or warranty of any kind, (i) terminates and cancels the Trademark Security Agreements, (ii) releases, discharges, terminates and

cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth Schedule 1 attached hereto, arising under the Security Agreement and the Trademark Security Agreements, and (iii) if and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral of any Grantor under the Security Agreement or the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest in to the applicable Grantor. Each Grantor, and any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral of such Grantor), is hereby authorized to record this release in the United States Patent and Trademark Office.

This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.




