RELEASE OF TRADEMARK SECURITY AGREEMENT

December 22, 2021

WHEREAS, pursuant to that certain Trademark Security Agreement, dated December 22, 2016, recorded in the United States Patent and Trademark Office at Reel 5955, Frame 0820 on January 5, 2017 (the "Trademark Security Agreement"), NEW STAR METALS INC., a Delaware corporation ("New Star"), WORLD CLASS CORRUGATING LLC, a Delaware limited liability corporation ("World Class"), CANFIELD COATING LLC, a Delaware corporation ("Canfield"), MATERIAL SCIENCES CORPORATION, a Delaware corporation ("MSC"), CONTINUOUS COLOUR COAT LIMITED, a corporation formed under the laws of the Province of Ontario ("Canadian Borrower"), ELECTRIC COATING TECHNOLOGIES LLC, a Delaware corporation ("ECT") and PREMIER RESOURCE GROUP LLC, an Illinois limited liability corporation ("Premier Resource", and together with New Star, World Class, Canfield, MSC, Canadian Borrower and ECT, each individually a "Releasee" and collectively, "Releasees"), created in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as agent (in such capacity, together with its successors and permitted assigns, "Releasor"), a security interest in all of the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, Releasees have requested and Releasor has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, intending to be legally bound and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby (i) terminates, releases, relinquishes and discharges its security interest in the Trademark Collateral, including without limitation, all of each Releasee's right, title and interest in and to the Trademark Collateral, including each trademark listed on Schedule 1 hereto, and (ii) reassigns, transfers and conveys to each Releasee any right, title and interest of the Releasor in the Trademark Collateral, in each case, without recourse or representation or warranty, express or implied, of any kind.
3. Authorization. Releasor hereby authorizes Releasees or Releasees' agent to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.
