TRADEMARK SECURITY RELEASE AGREEMENT

This TRADEMARK SECURITY RELEASE AGREEMENT, dated this 6 day of January, 2022 (this "Release") is made by JPMORGAN CHASE BANK, N.A. with a place of business at 8044 Montgomery Road, Suite 350, Cincinnati, Ohio 45236 (the "Secured Party"), under that certain GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of February 28, 2020 and recorded on March 31, 2020 in the records of the United States Patent and Trademark Office Assignment Branch at Trademark Reel/Frame 6890/0778 (the "Security Agreement"), between Secured Party and LITTLE BUSY BODIES, LLC, an Ohio limited liability company, located at 212 E. Third Street, Ste. 300, Cincinnati, Ohio 45202 (the "Debtor").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest in certain of the Debtor's United States trademarks and trademark applications and registrations and, in particular, the trademarks set forth on the attached Schedule A (the "Trademarks"); and

WHEREAS, the obligations underlying the security interest are no longer owed and the Secured Party no longer has any interest in the Trademarks; and

WHEREAS, the Secured Party wishes to: (i) release all of its security interest covering the Trademarks; (ii) restore all right, title, and interest in and to the Trademarks to the Debtor; and (iii) dissolve any and all liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quitclaims and relinquishes unto Debtor without recourse and without representation or warranty of any kind or nature, express or implied, any and all rights, title and interest it has in and to the Trademarks.

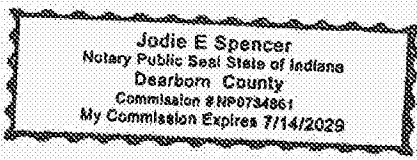
