**MEMORANDUM AND NOTICE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

**December 22, 2021**

**AROMATICA, INC.**, a California corporation ("Aromatica") and **HIGH QUALITY ORGANICS, INC.**, a Nevada corporation ("HQOI") and together with Aromatica each a "Borrower" and collectively "Borrowers"), whose address is 12101 Moya Blvd., Reno, Nevada 89506, hereby acknowledge that they have granted to **CITY NATIONAL BANK**, ("Lender"), whose address is 4275 Executive Square, Suite 750, La Jolla, California 92037, a security interest in and to all of such Borrower's and Guarantor's right, title and interest in and to: (a) the trademarks and trademark registrations and applications therefor (other than intent to use trademark applications to the extent excluded in the Agreement (as defined below)) which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by such Borrower and Guarantor ("Trademarks"), together with the goodwill and assets of the business.


Unless and until an Event of Default occurs and is continuing, Borrowers shall retain the legal and equitable title to the Trademarks and shall have the right to use and register the Trademarks, as applicable, in the ordinary course of the business of Borrowers. The terms and conditions of the aforementioned security interest are contained in that certain Loan and Security Agreement dated as of December 22, 2021 (the "Agreement"), among Borrower parties to the Agreement from time to time, the financial institutions party to the Agreement from time to time as lenders (collectively, "Lenders"), and Agent, as security for the Secured Obligations under and as set forth in the Agreement and other agreements referred to therein. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Agent may have in any other collateral described in the Agreement or otherwise. Capitalized terms used but not defined herein shall have the meaning given to such terms in the Agreement.


