**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Release”), dated as of February 1, 2022, is made by **ALLY BANK**, as Collateral Agent (“Collateral Agent”) in favor of **HOMERWOOD HARDWOOD FLOORING COMPANY, LLC** (“Homerwood”) and **AHF, LLC** (f/k/a Armstrong Hardwood Flooring Company) (“AHF”, and together with Homerwood, collectively, the “Grantor”). Capitalized terms used but not defined herein will have the meaning given to them in the IP Security Agreement (whether defined directly therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement among Grantor, Collateral Agent, and certain other parties, dated as of December 31, 2018 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), Grantor executed and delivered in favor of Collateral Agent that certain Intellectual Property Security Agreement dated as of December 31, 2018, which was recorded with the United States Patent and Trademark Office on (i) March 8, 2019 in its records at Reel 048544, Frame 0630 with respect to the patents thereunder (the “Patent Security Agreement”) and (ii) March 11, 2019 in its records at Reel 6586, Frame 0935 with respect to the trademarks thereunder (the “Trademark Security Agreement” and together with the Trademark Security Agreement, the “IP Security Agreement”);

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, Grantor granted to Collateral Agent a continuing lien on and security interest (the “Security Interest”) in all of Grantor’s right, title and interest in, to and under the Collateral (used herein as defined in the IP Security Agreement), including the Patents and Trademarks set forth in Schedule I; and

WHEREAS, Collateral Agent desires to release its rights and security interests in the Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby fully and finally (i) releases and terminates the Security Interest in the Collateral, and any and all other rights it may have under the IP Security Agreement, and (ii) hereby re-assigns to the Grantor any right, title or interest it may have in the Collateral.
