## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release"), dated as of January 11, 2022, is executed by ACF FINCO I LP, a Delaware limited partnership, in its capacity as Lender (the "Lender"), in favor of SUNDIA CORPORATION, a Delaware corporation ("Grantor"). All capitalized terms used in this Release and not otherwise defined herein, shall have the meaning given to such terms in the Memorandum and Notice of Security Interest (as defined below).

### RECITALS

WHEREAS, Grantor has, pursuant to that certain Trademark Assignment and Security Agreement dated as of January 26, 2018 by and among the Lender and Grantor (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office at Reel 006261, Frame 0530, granted a security interest to Lender in and to all of the Trademark Collateral, as defined in the Trademark Security Agreement, including without limitation those Trademarks listed on Exhibit A attached hereto (the "Released Collateral"); and

WHEREAS, the Lender wishes to terminate and release, without representation or warranty, its security interest in and to the Released Collateral as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender hereby (i) terminates, fully releases, discharges and cancels without recourse, representation or warranty, any and all security interest and lien in and to the Released Collateral, (ii) reassigns, grants and conveys to the Grantor any and all right, title and interest that it may have in and to the Released Collateral and (iii) terminates the Trademark Security Agreement. The Lender acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Lender authorizes the Grantor and its designees to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the security interest in the Released Collateral.


