RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of February 15, 2022, by Heritage Bank of Commerce ("Lender"), in favor of Yourpeople, Inc., a Delaware corporation ("Company"), with its principal place of business located at 50 Beale Street, San Francisco, California 94105.

Recitals

WHEREAS, Company granted to Lender a security interest in the intellectual property of Company, including without limitation, the trademark items and intellectual property listed on Exhibits A, B and C attached hereto (collectively, the "Intellectual Property"), under an Intellectual Property Security Agreement dated as of October 28, 2021 (the "Security Agreement") which was recorded with the US Patent and Trademark Office on October 28, 2021 at Reel Number 7476 and Frame Number 0659.

WHEREAS, Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender now desires and agrees to terminate and release the entirety of its security interest in the Intellectual Property.

Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth herein, Lender hereby agrees that the Security Agreement is terminated and Lender terminates, discharges and releases its security interest in the Intellectual Property and releases and reassigns to Company all right, title and interest of Lender in the Intellectual Property, including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), and any right, title or interest of Lender in the Intellectual Property shall hereby cease and become void.

THEREFORE, Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.

Lender authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release of Security Interest.
