RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of this 1st day of December, 2021, by JPMorgan Chase Bank, N.A., as administrative agent (in such capacity, "Agent") under the Term Facility Credit Agreement, dated as of December 6, 2018, by and among Fender Musical Instruments Corporation, the several lenders from time to time parties thereto and Agent, in favor of Fender Musical Instruments Corporation, a Delaware corporation ("FMIC") (the "Grantor").

For the purpose of the Release, (i) "Security Agreement" means the Guarantee and Collateral Agreement, dated as of December 6, 2018, by and among the Grantor and certain other parties, and Agent (as amended, supplemented or otherwise modified from time to time); and (ii) "Trademark Security Agreements" mean the following (as amended, supplemented or otherwise modified from time to time):

- 1) Grant of Security Interest in Trademark Rights, dated as of January 10, 2019, between FMIC and Agent, recorded with the United States Patent and Trademark Office ("PTO") on January 10, 2019, at Reel 6522, Frame 0198.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or, if not defined in the Security Agreement, in the applicable Trademark Security Agreement.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, relinquishes and discharges, all of its liens on and security interests in, to and under the trademark registrations and trademark applications listed on Schedule 1 (the "Trademarks") and re-assigns to Grantor any and all right, title or interest it may have in such Trademarks, which liens and security interests were established under and

pursuant to the Security Agreement and the Trademark Security Agreements recorded with the PTO.

The Agent hereby authorizes any Grantor, or any authorized representatives of the Grantor, to record this Release with the PTO and/or any other applicable governmental office or agency.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any conflict of law principles thereof.




