TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of February 18, 2022, and made by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors and assigns in such capacity, the "Agent"), to **ENTREDA, INC.**, a Delaware corporation, and **SMARSH INC.**, a New York corporation (each a "Grantor", and collectively the "Grantors").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 16, 2020, made by Grantors in favor of the Agent (the "Security Agreement"), a security interest was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral;

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on April 17, 2020 at Reel/Frame 6918/0208;

WHEREAS, the Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Agent hereby states as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement.

2. Release of Security Interest. The Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in all of the Grantors' right, title and interest of every kind and nature in the Trademark Collateral, including those Trademarks and Licenses referred to on Exhibit A hereto and reassigns to the person or persons legally entitled thereto all right, title and interest of the Agent (if any), in, to and under the Trademark Collateral.


