**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This Release of Security Interest in Intellectual Property Collateral, dated and made effective as of February 24, 2022 (this “**Release**”), is made by Cortland Capital Market Services LLC (the “**Agent**”), in favor of STAR CASES, LLC, a Delaware limited liability company (“**Star Cases**”) and STAR FORGE, LLC, a Delaware limited liability company (“**Star Forge**” and, together with Star Cases, the “**Grantors**”):

WITNESETH

WHEREAS, pursuant to that certain Term Loan Agreement, dated November 28, 2016 (“**Loan Agreement**”), the Grantors granted to the Agent a security interest in certain Collateral (as defined in the Security Agreements) and entered into that certain Grant of a Security Interest - Patents, dated November 28, 2016 (the “**Patent Security Agreement**”), which was recorded with the United States Patent and Trademark Office (“**USPTO**”), that certain Grant of a Security Interest -- Trademarks, dated November 28, 2016 (the “**Trademark Security Agreement**”), which was recorded with the USPTO, and that certain Grant of a Security Interest -- Copyrights, dated November 28, 2016 (the “**Copyright Security Agreement**,” and together with the Patent Security Agreement and the Trademark Security Agreement, the “**Security Agreements**”) filed with the United States Copyright Office (the “**USCO**”);

WHEREAS, pursuant to the Payoff Letter dated February 24, 2022 (“**Payoff Letter**”), the Agent has released all of Agent’s security interest in the Collateral, including those patents and patent registrations listed on Schedule 1 attached hereto, those trademarks and trademark registrations listed on Schedule 2 attached hereto, and those copyrights and copyright registrations listed on Schedule 3 attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged and as set forth in the Payoff Letter, the Agent hereby agrees to release and re-convey to the Grantors, without recourse, any and all of the Agent’s right, title and interest in and to its security interest in the Collateral as set forth in the Security Agreements, including those patents and patent registrations listed on Schedule 1 attached hereto, those trademarks and trademark registrations listed on Schedule 2 attached hereto, and those copyrights and copyright registrations listed on Schedule 3 attached hereto. In addition, the parties further agree as follows:

1. The Agent confirms that this Release may be filed with the USPTO and the USCO.
2. The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the terms and conditions of the Payoff Letter and this Release is expressly subject thereto.
3. Capitalized terms used but not defined herein shall have the meanings given to them in the applicable agreements.

4. Delivery of an executed signature page to this Release by facsimile or electronic transmissions (including .pdf file) shall be effective as delivery of an original signature.
