**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of March 1, 2022, by PNC BANK, NATIONAL ASSOCIATION (“PNC”), as Agent (as defined below), having an address at 2 International Place, 29th Floor, Boston, Massachusetts 02110, in favor of each of SCHYLLING INC., a Delaware corporation having an address at 21 High Street, Suite 400, North Andover, Massachusetts 01845, and STANNUM LLC, a Delaware limited liability company having an address at 21 High Street, Suite 400, North Andover, Massachusetts 01845 (together with their successors and assigns, collectively, the “Grantors”, and each, a “Grantor”).

WHEREAS, pursuant to that certain Trademark Assignment of Security, dated as of August 7, 2013 (the “Assignment”) by the Grantors in favor of Agent, and recorded in the United States Patent and Trademark Office on November 22, 2013, at Reel/Frame 5159/0342, the Grantors granted to PNC, as agent for itself and certain other financial institutions (PNC, in such capacity, “Agent”), a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, including the Marks listed on Schedule A hereto, together with the goodwill of the business symbolized by such trademark registrations and applications (collectively, the “Trademark Collateral”). Capitalized terms used but not defined herein shall have the meanings assigned to them in the Assignment.

WHEREAS, Agent wishes to terminate, release, relinquish and discharge its liens on and security interest in and to all of the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Agent hereby terminates, cancels, relinquishes, releases and discharges all liens and security interest in and to all of the Trademark Collateral and all claims of Agent against the Trademark Collateral, and any right, title and interest of Agent in the Trademark Collateral shall hereby cease and become void. Agent hereby conveys to each respective Grantor any interest in the foregoing.

Agent hereby authorizes and requests that the United States Patent and Trademark Office and any other applicable government officer record this Release.

THIS RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
