**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) is made as of this 1st day of March, 2022, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (“Agent”), in favor of LIGHTSPEED SOLUTIONS, LLC, a California limited liability company (“Grantor”).

WHEREAS, Grantor entered into a certain Intellectual Property Security Agreement, dated May 1, 2019, with Agent, notice of which was recorded with the United States Patent and Trademark Office on May 6, 2019 at reel/frame 6637/0564 and 049089/0756 (the “Security Agreement”). FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (a) releases, terminates and discharges its security interest in the Collateral, including the intellectual property listed on Schedule I attached hereto and made a part hereof, (b) terminates the Security Agreement and (c) assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may have in the Collateral of Grantor. Grantor, or any successor to Grantor (including any person or entity hereafter having any right, title or interest in or to the Collateral of Grantor), is hereby authorized to record this Release in the United States Patent and Trademark Office.
