**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) is made as of this 1st day of March, 2022, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (“Agent”), in favor of CATCHON, INC., a Delaware corporation (“Grantor”).

WHEREAS, Grantor entered into a certain Intellectual Property Security Agreement, dated January 31, 2022 with Agent, notice of which was recorded with the United States Patent and Trademark Office on January 31, 2022 at reel/frame 058836/0394 (the “Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the Security Agreement, a continuing security interest in favor of Agent, in and to all of their right, title and interest in and to the Collateral, including without limitation the intellectual property listed in Schedule I attached hereto.

WHEREAS, Agent has agreed to terminate and release its security interest in all such Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (a) releases, terminates and discharges its security interest in the Collateral, including the intellectual property listed on Schedule I attached hereto and made a part hereof, (b) terminates the Security Agreement and (c) assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may have in the Collateral of Grantor. Grantor, or any successor to Grantor (including any person or entity hereafter having any right, title or interest in or to the Collateral of Grantor), is hereby authorized to record this Release in the United States Patent and Trademark Office.
