## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made as of March 1, 2022 by Muzinich BDC, Inc., (the “**Secured Party**”), in favor of Microlab/FXR LLC (“**Grantor**”).

WHEREAS, Grantor granted a security interest in certain intellectual property to the Secured Party, as set forth in that certain Intellectual Property Security Agreement, dated as of February 7, 2020 (the “**IP Security Agreement**”), which was recorded with the Copyright Office on February 10, 2020 as Document no. V9978D136 and recorded with the U.S. Patent and Trademark office on February 7, 2020 at Reel 6859 and Frame 0982;

WHEREAS, the Secured Party desires to release the security interest held by the Secured Party in all IP Collateral (as defined in the IP Security Agreement) and reassign any and all rights in the same to the Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Secured Party hereby terminates and releases its lien on and security interest in, to and under all of the Grantor’s right, title and interest in, to and under all IP Collateral, including the copyright registration identified in Exhibit A and the trademark registration identified in Exhibit B, including all goodwill and other rights associated with any IP Collateral in which the Secured Party was granted a security interest pursuant to the IP Security Agreement. In addition, the Secured Party hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Secured Party, any and all of the Secured Party’s right, title and interest in, to and under the IP Collateral.

2. The Secured Party hereby authorizes and requests that the United States Patent and Trademark Office and the Copyright Office note and record the existence of the releases hereby given.
