NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:



The Lender hereby (a) authorizes Grantor or its authorized representatives to record this Release of Security Interest (the “**Release**”) with the U.S. Patent and Trademark Office and (b) authorizes and requests that the U.S. Patent and Trademark Office note and record the existence of this Release hereby given, at Grantor’s sole cost and expense.
