RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Trademark Security Agreement Supplement was recorded with the United States Patent and Trademark Office on May 13, 2021 at Reel/Frame 007284/0518;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

- 1. <u>Definitions</u>. Unless otherwise defined herein, capitalized terms used in this Release have the meaning given to them in the Trademark Security Agreement or the Guarantee and Collateral Agreement, as applicable.
- 2. <u>Release</u>. The Administrative Agent, without representation, warranty or recourse of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the trademark registrations set forth in the Trademark Security Agreement Supplement (such trademark registrations, the "<u>Released Trademark Collateral</u>") as listed in Schedule 1 hereto.

- 3. <u>Governing Law</u>. This Release shall exclusively be governed by, and construed in accordance with, the laws of the state of New York, without regard to conflicts of law or choice of law principles.
- 4. <u>Counterparts</u>; <u>Signatures</u>. This Release may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument. Delivery of an executed signature page to this agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this agreement.
