

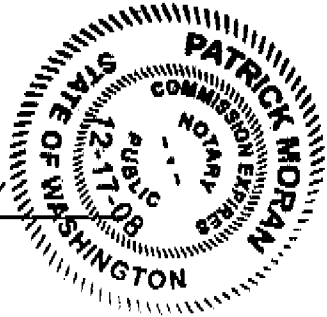


**AFFIDAVIT**
