## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of May 2, 2022 ("Effective Date") by WILMINGTON TRUST, N.A., as collateral agent, with its principal office at 1100 North Market Street, Wilmington, Delaware 19890, USA ("Collateral Agent"), in favor of SIMPLISAFE, INC., a Delaware corporation, with its principal office at 294 Washington St., Boston, Massachusetts 02108, USA ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain SECOND LIEN TRADEMARK SECURITY AGREEMENT by and between Grantor and the Collateral Agent dated February 12, 2021 (the "Trademark Security Agreement"), Grantor granted to the Collateral Agent for the benefit of the Secured Parties a Security Interest in all of Grantor's right, title and interest in and to United States Trademark registrations and applications (collectively, the "Trademark Collateral"), including, without limitation, the United States Trademark registrations and applications set forth on Schedule A attached hereto;

**WHEREAS**, Grantor and the Collateral Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain SECOND LIEN SECURITY AGREEMENT by and between Grantor, the Collateral Agent and the other parties thereto, dated February 12, 2021 (the "Security Agreement");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on February 12, 2021, at Reel 7191, Frame 0851; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to the Collateral Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges and releases all of its Security Interest in the Trademark Collateral, including the United States Trademark registrations and applications set forth on Schedule A attached hereto, if any, and any right, title or interest of the Collateral Agent in the Trademark Collateral shall hereby cease and become void. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral, including the United States Trademark registrations and applications set forth on Schedule A attached hereto, if any, the Collateral Agent hereby re-transfers, re-conveys, and re-assigns such right, title or interest to the Grantor.

The Collateral Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any of its Security Interest in the Trademark Collateral and; (iii) it has not recorded or otherwise evidenced its Security Interest with respect to any Trademark Collateral, other than those Trademarks set forth on Schedule A attached hereto, if any, in any jurisdiction throughout the world.

The Collateral Agent hereby agrees to take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release. The Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Release.


Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement or the Security Agreement, as applicable.
