**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY
SECURITY INTEREST**

May 6, 2022

WHEREAS, by (a) an Intellectual Property Security Agreement, dated as of September 7, 2018 (as amended, supplemented or otherwise modified from time to time, the “2018 Security Agreement”), recorded with the United States Patent and Trademark Office at Trademark Reel/Frame 6432/0701 and Patent Reel/Frame 047030/0785 and (b) an Intellectual Property Security Agreement, dated as of June 11, 2021 (as amended, supplemented or otherwise modified from time to time, the “2021 Security Agreement” and together with the 2018 Security Agreement, the “Security Agreements”), recorded with the United States Patent and Trademark Office at Trademark Reel/Frame 7325/0515 and Patent Reel/Frame 056587/0130, Cenveo Worldwide Limited, LightningLabels.com, LLC and ICONEX LLC (each, an “Assignor” and collectively, the “Assignors”), assigned to and granted to Wilmington Savings Fund Society, FSB, as administrative agent and collateral agent (the “Assignee”), a security interest in all right, title and interest of the Assignors in and to the trademarks and patents listed on Schedule A hereto (the “Intellectual Property”) as well as other trademarks and patents;

WHEREAS, Assignee wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the termination, release, relinquishment, discharge and cancellation of the Security Agreements and all of its security interest in the Intellectual Property listed on Schedule A hereto; and

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Assignee hereby terminates, relinquishes, releases, discharges and cancels the Security Agreements and all of its security interest in the Intellectual Property listed on Schedule A hereto, without recourse or representation or warranty, express or implied, of any kind.

1. Further Assurances. The Assignee agrees to take all further actions, and provide to each Assignor all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Assignor, to more fully and effectively effectuate the purposes of this Release of Intellectual Property Security Interest (this “Release”).

2. Counterparts. This Release may be executed in any number of counterparts, all of which taken together shall constitute one agreement, and any of the parties hereto may execute this Release by signing any such counterpart. Each Assignor acknowledges that delivery of an executed counterpart of a signature page of this Release by fax or electronic mail transmission shall be effective as delivery of a manually executed counterpart of this Release.

3. Severability. Any provision in this Release that is held to be inoperative, unenforceable or invalid in any jurisdiction shall, as to that jurisdiction, be inoperative, unenforceable or invalid without affecting the remaining provisions in that jurisdiction or the operation, enforceability or validity of that provision in any other jurisdiction, and to this end the provisions of this Release are declared to be severable.

4. Governing Law. This Release and any right, remedy, obligation, claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Release shall be governed by, and construed in accordance with, the law of the State of New York.


