**PARTIAL TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY  
SECURITY AGREEMENT**

**THIS PARTIAL TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “Release”), is dated as of June 10, 2022 and made by and among **PNC BANK, NATIONAL ASSOCIATION** (“Grantee”), in its capacity as lender under the below-defined Security Agreements, and **TRANSTAR INDUSTRIES LLC**, an Ohio limited liability company (“Transtar”), **TRANSTAR AUTOBODY TECHNOLOGIES LLC**, an Ohio limited liability company, **AXIOM AUTOMOTIVE TECHNOLOGIES LLC**, a Delaware limited liability company, **ATCO PRODUCTS LLC**, a Delaware limited liability company, **DACCO LLC**, an Ohio limited liability company and **TRANS MART, INC.**, a Puerto Rico corporation (each a “Grantor”, and collectively the “Grantors”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of October 11, 2018 (the “IPSA”), made by the Grantors in favor of Grantee, a security interest was granted by the Grantors to Grantee, in certain collateral, including the Specified IP Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Assignment dated as of June 2, 2021 (the “Assignment”, and together with the IPSA, the “Security Agreements”), between Transtar and **NICKELS PERFORMANCE LLC** (“Nickels”), Transtar assigned its entire right, title and interest in and to the Specified IP Collateral (as hereinafter defined) to Nickels;

WHEREAS, the IPSA and Assignment were recorded with the trademark division of the United States Patent and Trademark Office on October 23, 2018 at Reel/Frame 6463/0689 and on June 3, 2021 at Reel/Frame 007314/0932, respectively;

WHEREAS, Grantee now desires to terminate and release its security interest in the Specified IP Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Grantee hereby states as follows:

1. Definitions. The term “Specified IP Collateral,” as used herein, means all of the Grantors’ right, title and interest in the trademarks and copyrights listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates, releases and discharges its security interest in the Specified IP Collateral and reassigns to the person or persons legally entitled thereto all of its right, title and interest in the Specified IP Collateral. Grantee acknowledges that this Release may be filed with the United States Patent and Trademark Office, United States Copyright Office or any other governmental office to evidence the partial termination and release granted by this Release. Grantee agrees to take all further actions reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.
