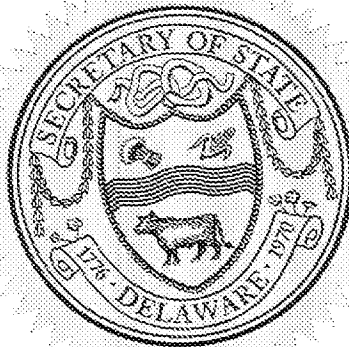

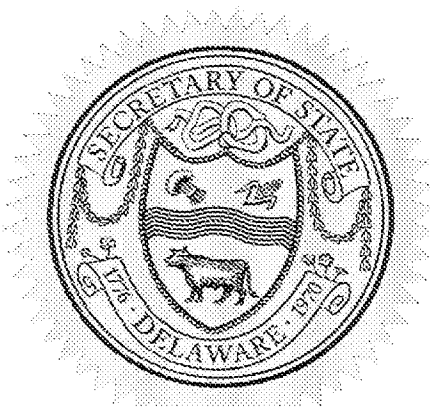

Pursuant to Title 8, Section 264(c) of the General Corporation Law of the State of Delaware and Title 6, Section 18-209 of the Delaware Limited Liability Company Act, Frito-Lay, Inc., a Delaware corporation ("FLI"), does hereby certify as follows:

1. Medora Snacks, LLC ("**Medora**") is a limited liability company duly formed and existing under the laws of the State of Delaware, and FLI is a corporation organized and existing under the laws of the State of Delaware.
2. The Medora Agreement and Plan of Merger, dated as of December 23, 2020 (the "**Merger Agreement**"), between Medora and FLI, setting forth the terms and conditions of the merger of Medora with and into FLI (the "**Merger**"), has been approved, adopted, certified, executed and acknowledged by each of Medora and FLI in accordance with Section 264 of the General Corporation Law of the State of Delaware and Section 18-209 of the Delaware Limited Liability Company Act.
3. The surviving entity of the Merger (the "**Surviving Company**") shall be FLI and the name of the Surviving Company shall be Frito-Lay, Inc.
4. The executed Merger Agreement is on file at the place of business and office of the Surviving Company at 7701 Legacy Drive, Plano, TX 75024-4099.
5. A copy of the Merger Agreement will be furnished by the Surviving Company on request, without cost, to the shareholder of FLI or member of Medora.
6. The Merger shall be effective on December 23, 2020.
