**NUNC PRO TUNC TRADEMARK ASSIGNMENT OF RIGHTS**

This *Nunc Pro Tunc* Trademark Assignment of Rights is effective as of April 17, 2014, and is entered into by and between ReBath, LLC, a Delaware limited liability company, with an address of 426 North 44th Street, Suite 410, Phoenix, Arizona 85008 (“Assignor”) and Arizona Ambath, LLC, a Delaware limited liability company, with an address of 23233 N Pima #113-158, Scottsdale, Arizona 85255 (“Assignee”).


