**TRADEMARK ASSIGNMENT**

This Trademark Assignment ("Assignment") between Twitter, Inc., a Delaware corporation with its principal place of business at 1355 Market Street, Suite 900, San Francisco, California 94103 ("Assignee"), and Tweet Love, LLC, a Tennessee limited liability company with its principal place of business at 9676 Old Highway 46, Bon Aqua, Tennessee, 37025 ("Assignor") is effective as of the date when it has been fully executed below ("Assignment Effective Date").

Assignor does hereby sell, assign, transfer and set over to Assignee the Assignor's entire right, title and interest in and to the Assigned Trademark Rights together with the Assignor's goodwill in connection with which the Trademark are used, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made, together with all income, royalties or payments in respect of the Assigned Trademark Rights due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Assigned Trademark Rights, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. The assignment of the Assigned Trademark Rights accompanies the transfer of the portion of Assignor's business to which the Assigned Trademark Rights pertain, as required by Section 10 of the Trademark Act, 15 U.S.C. §1060, and that said business is ongoing and existing.
