TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Termination and Release”), dated as of June 23, 2022, is made by LBC CREDIT AGENCY SERVICES, LLC (“LBC”), as agent (the “Agent”), in favor of the Grantor (as defined below).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 21, 2018, entered into pursuant to that certain Security Agreement, dated as of June 21, 2018, (as amended, restated, supplemented or otherwise modified from time to time), and recorded with the Trademark Division of the United States Patent and Trademark Office on June 21, 2018 at Reel/Frame 006359/0808 (the “Trademark Security Agreement”), a lien on and security interest (the “Security Interest”) was granted by SKYLINE TENT COMPANY, a Delaware corporation (the “Grantor”) to the Agent in the Trademark Collateral;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein shall have the meanings set forth in the Trademark Security Agreement.
2. Release of Security Interest. The Agent, without representation, warranty or recourse, hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all Security Interest in the Trademark Collateral, including but not limited to the Trademarks set forth on Schedule I hereto, and any right, title or interest of the Agent in the Trademark Collateral shall hereby cease and become void, and hereby assigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Agent, any and all of the Agent’s right, title and interest in and to the Trademark Collateral.
3. Recordation. The Agent authorizes Grantor and its agents and designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority or agency at Grantor’s expense.
4. Further Assurances. The Agent further agrees to execute and deliver to the Grantor and its agents and designees any and all further documents and instruments, and do any and all further acts which the Grantor (or its agents or designees) reasonably request (at the Grantor's expense) in order to carry out the purposes of this Termination and Release and confirm the Grantor’s right, title and interest in, to and under the Trademark Collateral.
5. Choice of Law. THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER AND ALL CLAIMS AND CONTROVERSIES ARISING OUT OF THE SUBJECT MATTER HEREOF (WHETHER SOUNDING IN CONTRACT LAW, TORT LAW OR OTHERWISE) SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PROVISIONS THAT WOULD RESULT IN THE APPLICATION OF ANY OTHER LAW (OTHER THAN ANY MANDATORY PROVISIONS OF LAW

RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).
