**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of June 23, 2022 (this “Release”) is made by JPMorgan Chase Bank, N.A., as administrative agent for a group of lenders (in such capacity, together with its successors and permitted assigns, the “Agent”) in favor of Atlantic Pacific Equipment, LLC, a Delaware limited liability company (formerly known as Atlantic Pacific Equipment, Inc., a Georgia corporation, the “Grantor”).

Pursuant to the Security Agreement, dated as of May 13, 2015 entered into by the Grantor, each other grantor party thereto, and Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), Grantor and Agent entered into a certain Notice of Grant of Security Interest in U.S. Trademarks, dated as of March 8, 2018 and recorded in the United States Patent and Trademark Office on March 9, 2018, at Reel 6288, Frame 0648 (the “Trademark Security Agreement”), and pursuant to the Security Agreement and Trademark Security Agreement, the Grantor granted to the Agent a continuing security interest in, all of its right, title and interest in, to and under the trademarks identified on Schedule A hereto and incorporated herein by reference (the “Trademarks”).

The Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the collateral assignment and pledge in and all of its lien on and security interest in, all right, title and interest in, to and under the Trademarks. Any right, title or interest of the Agent in such Trademarks shall hereby cease and become void.

The Agent hereby authorizes the Grantor or the Grantor’s authorized representative to (i) record this Release with the United States Patent and Trademark Office, and/or (ii) otherwise record or file this Release in the applicable governmental office or agency.

This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery by telecopier or by electronic .pdf copy of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.
