RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY INTERESTS (this "Release"), dated as of June 24, 2022, is made by Adams Street Credit Advisors LP (as successor to Wells Fargo Bank, National Association ("Wells Fargo"), in its capacity as agent for each member of the Lender Group and Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Agent") in favor of Grantor (as defined below).

WHEREAS, (i) PlayMonster LLC, a Delaware limited liability company ("PlayMonster"), Roominate, LLC, a Delaware limited liability company ("Roominate") are party to that certain Trademark Security Agreement dated November 16, 2018, (the "2018 IP Agreement") in favor of Wells Fargo Bank, National Association ("Wells Fargo"), and subsequently amended by Amendment No. 1 to the Trademark Security Agreement dated as of November 8, 2019, ("Amendment No. 1"), and (ii) Ann Williams Group, LLC, a Delaware limited liability company ("Ann Williams", together with PlayMonster and Roominate, each an "Original Grantor", and, collectively, the "Original Grantors") is party to that certain Trademark Security Agreement dated July 22, 2021, (the "2021 IP Agreement", together with the 2018 IP Agreement and Amendment No. 1, the "IP Agreements") in favor of Wells Fargo;

WHEREAS, Wells Fargo and Agent are party to that certain Assignment of Trademark Security Interests dated January 24, 2022 (the "ASP Assignment Agreement"), pursuant to which Wells Fargo assigned all of its security interest, continuing lien and other rights in, to and under the Trademark Collateral (as defined in the IP Agreements) to Agent;

WHEREAS, (i) Ann Williams and PlayMonster are party to that certain Trademark Assignment dated January 21, 2022 (the "PlayMonster Assignment"), pursuant to which Ann Williams assigned its right, title and interest in, to and under its Trademark Collateral to PlayMonster, (ii) Roominate and PlayMonster Group, LLC, a Delaware limited liability company ("Grantor") are party to that certain Trademark Assignment dated January 21, 2022 (the "Roominate Assignment"), and (iii) PlayMonster and Grantor are party to that certain Trademark Assignment dated January 24, 2022 (the "PMG Assignment", collectively with the ASP Assignment Agreement and the PlayMonster Assignment, the "Assignment Agreements"), pursuant to which each of the Original Grantors assigned its right, title and interest in, to and under the Trademark Collateral to Grantor; capitalized terms used but not defined herein will have the meaning given to them in the Assignment Agreements, as applicable;

WHEREAS, the Agreements granted to Agent a continuing security interest in all right, title and interest of the Grantors in, to and under the Trademark Collateral, including those listed on Schedule I hereto, together with, among other things, all renewals and extensions, all goodwill of the business connected with the use of, and symbolized by, such Trademark and all products and proceeds (as that term is defined in the UCC) of the foregoing, including any (i) claim the Grantor against third parties for past, present or future infringement, dilution or other violation of any Trademark, including right to receive any damages and to sue in the name of the Grantor, (ii) injury to the goodwill associated with any Trademark of the Grantor, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License;

WHEREAS, the 2018 IP Agreement was recorded with the U.S. Patent and Trademark Office at Reel/Frame 6483/0569;

WHEREAS, Amendment No. 1 was recorded with the U.S. Patent and Trademark Office at Reel/Frame 6885/0420;

WHEREAS, the 2021 IP Agreement was recorded with the U.S. Patent and Trademark Office at Reel/Frame 7363/0382;

WHEREAS, the ASP Assignment Agreement was recorded with the U.S. Patent and Trademark Office at Reel/Frame 7567/0643; and

WHEREAS, the PlayMonster Assignment was recorded with the U.S. Patent and Trademark Office at Reel/Frame 7713/0573;

WHEREAS, the PMG Assignment was recorded with the U.S. Patent and Trademark Office at Reel/Frame 7659/0120; and

WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Release. Agent hereby (i) fully and finally releases, discharges, and terminates, and reassigns to the Grantor, without representation or warranty of any kind, (a) its security interest, continuing lien and other rights in, to and under the Trademarks, including the goodwill of the business symbolized by the Trademark Collateral, and (b) any and all other rights it may have under the IP Agreements, (ii) agrees that it shall, at the expense of Grantor, execute all other documents and do all other acts reasonably necessary to relinquish and effect the release of such rights and (iii) authorizes and requests that the U.S. Patent and Trademark Office note and record the release hereby given and any other filings reasonably necessary to evidence release and termination of its rights under the IP Agreements with respect to the Trademark Collateral.

2. Counterparts. This Release may be executed in any number of counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Release by telecopy or other electronic means shall be effective as delivery of a manually executed counterpart of this Release.

3. Governing Law. This Release and the rights and obligations of the parties hereunder shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


