TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Assignment") is made effective as of 7/7/2022 ("Effective Date") by and between Four State International Trucks, Inc., a Missouri corporation, DBA 4 State Trucks Inc. with an address of P.O. Box 1691 Joplin, MO 64802 ("Assignor"), and Best Fit Truck Parts, LLC, a Missouri limited liability company with an address at P.O. Box 1691 Joplin, MO 64802 ("Assignee").

WHEREAS, Assignee is wholly-owned by Assignor;

WHEREAS, Assignor is the current owner of all right, title and interest in and to the trademarks specified on Exhibit A ("Trademarks") hereto along with the goodwill associated therewith;

WHEREAS, Assignor now wishes to assign to Assignee the Trademarks along with goodwill associated therewith; and

WHEREAS, Assignee, as a wholly owned subsidiary of Assignor, desires to acquire and assume all of Assignor's right, title and interest in and to the Trademarks along with the goodwill associated therewith.

NOW, THEREFORE, for Ten Dollars (\$10.00) and other valuable consideration furnished by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree to the following:

1. Trademark Assignment. Assignor hereby assigns, transfers, sells, and conveys to Assignee its entire right, title, and interest in and to the Trademarks, including all goodwill associated with the Trademarks and of the business connected with the use of and symbolized by the Trademarks, and the right to sue for and the remedies resulting from past and future infringement of the foregoing, and rights of protection of interest therein under the laws of all jurisdictions. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all Trademarks to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct. Assignor covenants, agrees and undertakes to execute, wherever reasonably requested by the Assignee, all assignments, lawful oaths and any other papers which Assignee may deem reasonably necessary for securing to Assignee or for maintaining for Assignee the Trademarks, all without further compensation to the Assignor.

2. General. Unless otherwise specified in this Assignment, this Assignment contains the entire agreement of the parties and supersedes any and all prior agreements, written or oral, between Assignor and Assignee relating to the subject matter of this Assignment. This Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. This Assignment may not be amended except by an instrument in writing signed by each of the parties hereto.
