RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of July 12, 2022 (this “Release”), is made by ENTERPRISE BANK & TRUST, a Missouri chartered trust company, as a Lender and in its capacity as agent (acting in such capacity, including its successors and assigns, “Secured Party”) in favor of CORONIS HEALTH, LLC, a Delaware limited liability company, MEDICAL MASTERMIND, LLC, a Delaware limited liability company, CRT MEDICAL SYSTEMS, INC., a Michigan corporation, PAR GROUP, INC., a Michigan corporation, CRT EMPLOYEE LEASING, LLC, a Michigan limited liability company, CRT HEALTH, LLC, a Delaware limited liability company, PHYSICIAN DATA MANAGEMENT, LLC, a Delaware limited liability company, KSL BILLING & MANAGEMENT, LLC, a Delaware limited liability company, MEDICAL ACCOUNT SERVICES, LLC, a Delaware limited liability company, CRT MEDICAL, LLC, a Delaware limited liability company, AVEC HEALTH, LLC, a Delaware limited liability company, M.L. MEDICAL BILLING COMPANY, an Illinois corporation, CORONIS GLOBAL, LLC, a Delaware limited liability company, MSOC, LLC, a Delaware limited liability company, ML BILLING, LLC, a Delaware limited liability company, and SUPPORTMED, LLC, a Delaware limited liability company (individually and collectively, the “Debtor”). Capitalized terms used and not otherwise defined herein have the meanings given to them in the Primary Security Agreement.

WITNESSETH

WHEREAS, Debtor, Secured Party, and the other parties party thereto from time to time, are parties to that certain Amended and Restated Loan and Security Agreement, dated as of October 23, 2019 (the “Primary Security Agreement”);

WHEREAS, pursuant to the Primary Security Agreement, Debtor executed the Amended and Restated Trademark Security Agreement, dated as of October 23, 2019 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on January 16, 2020 at Reel/Frame Nos. 6839/0166 and 6839/0178, pursuant to which Debtor granted to Secured Party, for the benefit of Lenders, a valid and perfected first priority security interest in all of Debtor’s right, title, and interest in, to and under the Collateral (as defined in the Trademark Security Agreement);


WHEREAS, Debtor has requested that Secured Party release its security interest in and to all of its right, title and interest in, to and under the Collateral.

NOW, THEREFORE, in consideration of the foregoing, Secured Party hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to Debtor, without recourse, representation or warranty, any and all right, title and interest that Secured Party may have obtained in, to and under the Collateral under the Primary Security Agreement and the Trademark Security Agreement.
