RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of July 12, 2022 (this "Release"), is made by ENTERPRISE BANK & TRUST, a Missouri chartered trust company, as a Lender and in its capacity as agent ("Agent") in favor of RELIABILL, LLC, a Delaware limited liability company ("Grantor"). Capitalized terms used and not otherwise defined herein have the meanings given to them in the Primary Security Agreement.

WHEREAS, Grantor, Agent, and the other parties party thereto from time to time, are parties to that certain Amendment No. 1 to Amended and Restated Loan and Security Agreement and Omnibus Amendment to Loan Documents, dated as of February 28, 2020 (the "Agreement");

WHEREAS, pursuant to the Agreement, Grantor executed the Notice of Grant of Security Interest in Trademarks, dated as of February 28, 2020 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on March 11, 2020 at Reel/Frame No. 6888/0613, pursuant to which Grantor granted to Agent, for the benefit of Lenders, a continuing security interest in and to, Grantor's right, title and interest in and to the trademarks set forth on Schedule I attached hereto and incorporated herein by reference (the "Trademark Collateral");


WHEREAS, Grantor has requested that Agent release its security interest in and to all of its right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to Grantor, without recourse, representation or warranty, any and all right, title and interest that Agent may have obtained in, to and under the Trademark Collateral under the Agreement and the Trademark Security Agreement.
