**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of December 17, 2020 by **BANK OF AMERICA, N.A.** and **BANK OF AMERICA CORPORATION** (collectively the “**Bank**”), in favor of **NOBULL, LLC**, a Delaware limited liability company, and **NOBULL HOLDINGS, INC.**, a Delaware corporation, (collectively the “**Pledgor**”).

**WHEREAS**, the Pledgor executed and delivered an Intellectual Property Security Agreement dated as of April 6, 2020 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Grant**”), granting the Bank a security interest in and lien on certain trademarks and trademark applications (“**Marks**”) described therein, which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on April 9, 2020, at Reel 6912, Frame 0192;

**WHEREAS**, the Pledgor has requested that the Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Pledgor in, to and under all of the **Marks** as herein provided; and

**WHEREAS**, the Pledgor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank’s security interests in and liens on the **Marks** as herein provided.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the **Grant** and releases, terminates and discharges all liens and security interests in the Pledgor’s right, title and interest in, to and under the **Marks**, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule A hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
