**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “**Release**”) is granted on this 24th day of June, 2022, by Wilmington Trust, National Association, as Collateral Agent (in such capacity, the “**Notes Collateral Agent**”), in favor of Clark Equipment Company (“**CEC**” or the “**Grantor**”) with respect to the Trademark Collateral (as defined below). CEC is a wholly owned subsidiary of Doosan Bobcat Inc. (“**Parent**”).

**W I T N E S S E T H :**

WHEREAS, the Grantor and the Notes Collateral Agent are party to that certain Security Agreement, dated as of May 29, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) entered into pursuant to that certain Indenture, dated as of May 29, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time) by and among CEC, Parent, as guarantor, and Wilmington Trust, National Association, in its capacity as the trustee and Notes Collateral Agent, respectively, pursuant to which CEC issued \$300,000,000 aggregate principal amount of its 5.875% Senior Secured Notes due 2025 (the “**Notes**”) on May 29, 2020 and may have from time to time issued additional Notes upon the terms and subject to the conditions set forth therein;

WHEREAS, on May 29, 2020, the Notes Collateral Agent and the Grantor entered into a Trademark Security Agreement, which was recorded with the U.S. Patent and Trademark Office on June 1, 2020, at Reel/Frame 6949/0807 (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor granted to the Notes Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined below); and

WHEREAS, the Notes Collateral Agent acknowledges that all the outstanding Obligations have been indefeasibly paid in full, and as a result desires to release, terminate and discharge any and all security interests, and any other lien, it has in the Trademark Collateral.

NOW THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Notes Collateral Agent hereby agrees as follows:

1. The Notes Collateral Agent hereby absolutely, unconditionally and irrevocably releases, terminates and forever discharges, without recourse, representation or

warranty each security interest in any and all right, title and interest that it may have in, to and under any and all trademarks, trade names, corporate names, company names, business names, fictitious business names, service marks, logos and other source or business identifiers, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, including, without limitation, any of the foregoing referred to in Schedule A hereto, together with the goodwill connected with the use thereof and symbolized thereby, all extensions and renewals thereof, and the right to receive all proceeds therefrom, in each case arising under the Security Agreement and the Trademark Security Agreement (collectively, the “**Trademark Collateral**”), and any and all other security interests or liens that the Notes Collateral Agent or its predecessors, successors and assigns may have in or to the Trademark Collateral under the Security Agreement or the Trademark Security Agreement.

2. The Notes Collateral Agent hereby authorizes that the Commissioner for Trademarks and any other applicable government officer record this Release.
3. This Release and the rights and obligations of the parties under this Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
4. All defined terms not otherwise defined in this Release shall have the meanings set forth in the Security Agreement.
5. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
