**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of August 22, 2022 (the “Effective Date”), by **CITIZENS BANK, N.A.**, as collateral agent (in such capacity, the “Collateral Agent”), in favor of **APOGEE TELECOM, INC.**, a Texas corporation (“Telecom”), **CAMPUS CONNECT, LLC**, a Texas limited liability company (“Campus Connect”) and **CAMPUS TELEVIDEO, INC.**, a Connecticut corporation (“CTV”) and together with Telecom and Campus Connect, each a “Grantor” and together the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below), or if not defined therein, in the Credit Agreement (as defined below).

**WHEREAS**, reference is made to (a) that certain Credit and Guaranty Agreement, dated as of June 26, 2017 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among Telecom, the other Credit Parties party thereto (including the other Grantors), the Collateral Agent (including in its capacity as the Administrative Agent thereunder), and the Lenders party thereto, and (b) the Pledge and Security Agreement dated as of June 26, 2017 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the grantors party thereto (including the Grantors), and the Collateral Agent;

**WHEREAS**, pursuant to the Security Agreement, the Grantors and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of June 26, 2017, which was recorded with the United States Patent and Trademark Office on June 27, 2017 at Reel 6091, Frame 0478 (as amended, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”);

**WHEREAS**, pursuant to the terms of the Trademark Security Agreement, the Grantors granted to the Collateral Agent, on behalf of itself and the Secured Parties, a continuing first priority security interest in all of Grantors’ right, title and interest in, to and under the following, whether presently existing or thereafter created or acquired (collectively, the “Trademark Collateral”):

- (a) all of its Trademarks and Trademark Licenses to which it is a party including those referred to on **Schedule I** hereto;
- (b) all reissues, continuations or extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
- (d) all products and proceeds of the foregoing, including, without limitation, any claim by either Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.


**WHEREAS**, the Collateral Agent now desires to release its security interest in the Trademark Collateral.
