RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of August 29, 2022 (the “Effective Date”), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Administrative Agent (the “Agent”), in favor of the grantor parties identified on the signature page hereto (each a “Grantor,” and, collectively, the “Grantors”).

WHEREAS, pursuant to that certain Security Agreement, dated as of July 2, 2018, by and among the Agent, the Grantors and certain other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Trademark Security Agreement, dated as of July 2, 2018 (the “July 2018 Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the July 2018 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 5, 2018 at Reel/Frame 6401/0586;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Supplemental Trademark Security Agreement, dated as of March 5, 2019 (the “March 2019 Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the March 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 6, 2019 at Reel/Frame 6582/0812;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Supplemental Trademark Security Agreement, dated as of May 21, 2019 (the “May 2019 Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the May 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 23, 2019 at Reel/Frame 6652/0168;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Supplemental Trademark Security Agreement, dated as of December 20, 2019 (the “December 2019 Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the December 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 20, 2019 at Reel/Frame 6823/0170;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Supplemental Trademark Security Agreement, dated as of as of September 27, 2021 (the “September 2021 Trademark Security Agreement” and, together with the July 2018 Trademark Security Agreement, the March 2019 Trademark Security Agreement, the May 2019 Trademark Security Agreement and the December 2019 Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the September 2021 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 6, 2021 at Reel/Frame 7443/0713;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and trademark applications set forth on Schedule 1 attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantors.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.


5. Governing Law. This Release and the transactions contemplated hereby, and all disputes between the parties under or relating to this Release or the facts or circumstances leading to its execution, whether in contract, tort or otherwise, shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.

6. Counterparts. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts. The words "execution," "signed," and words of like import in this Release shall be deemed to include electronic signatures or electronic records, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.
