RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (this “Release”) is effective as of September 6, 2022 by HPS Investment Partners, LLC, as collateral agent (together with its successors and assigns, “Collateral Agent”).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of June 7, 2021, executed by, among others BECKETT COIN & ROCK, LLC, a North Carolina limited liability company (“Grantor”), in favor of Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), Grantor granted to Collateral Agent a continuing security interest in and continuing lien upon all of the Intellectual Property Collateral (as such term is defined in the Security Agreement) of Grantor, including, without limitation, the trademarks listed on Exhibit A hereto;

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on June 14, 2021 at Reel/Frame 7325/0275; and

WHEREAS, the Security Agreement was recorded with the United States Copyright Office on July 8, 2021 with Volume/Doc. No. 9986/006;

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Collateral Agent hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Intellectual Property Collateral (as defined in the Security Agreement), without any recourse, representation or warranty, (ii) terminates the Security Agreement, and (iii) re-assigns to Grantor, any right, title or interest Collateral Agent may have in, to or under the Intellectual Property Collateral, together with the goodwill of the business symbolized thereby, in each case solely with respect to the Intellectual Property Collateral of Grantor (as defined herein) and excluding, for the avoidance of doubt, any Intellectual Property Collateral of any other grantor party to the Security Agreement, and hereby authorizes Grantor or Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office and the United States Copyright Office as evidence of such release and termination.


