## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 19, 2022 (“Release”), is made by **PNC BANK, NATIONAL ASSOCIATION**, a national banking association, (“Agent”), in favor of **AEOLUS DOWN, INC.**, a California corporation (the “Grantor”).

**WHEREAS**, pursuant to (i) that certain Revolving Credit, Term Loan and Security Agreement dated as of September 27, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Loan Agreement”) by and among the Grantor, Agent, and others party thereto and (ii) that certain Trademark Security Agreement dated as of September 27, 2013 by and among the Grantor and Agent (“Trademark Agreement”), Grantor granted to the Agent, a lien on and security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Agreement);

**WHEREAS**, the Trademark Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on October 2, 2013 at Reel 5122 Frame 0646.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, and Grantor agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement or Trademark Agreement.

**SECTION 2. Termination and Release.** Agent, without representation, warranty, or recourse, hereby:


(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the Grantor’s right, title, and interest in, to, and under the Trademark Collateral (as defined in the Trademark Agreement), including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Loan Agreement and the Trademark Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Agent has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
