**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 7th day of December, 2022, by LBC CREDIT AGENCY SERVICES, LLC, in its capacity as agent ("Agent"), in favor of INDUSTRIAL AIR POWER LLC, a Wisconsin limited liability company ("Grantor").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases all liens on and security interests in all of its right, title and interest in, to and under the following Collateral of Grantor: (i) all of its Trademarks and all Intellectual Property Licenses providing for the grant by or to Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule A attached hereto, (ii) all renewals and extensions of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark, and (iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the "Trademark Collateral"). If and to the extent that the Agent has acquired any right, title or interest in, to or under the Trademark Collateral of the Grantor, the Agent hereby assigns, transfers and conveys to the Grantor any interest in Trademark Collateral.


This Release may be executed in any number of counterparts, all of which when taken together shall constitute one and the same instrument, and of the parties hereto may execute this Release by signing any such counterparty, with the same effect as if the signatures thereto and hereto were upon the same instrument. Signature by facsimile, .pdf or other electronic signature shall bind the parties thereto.

This Release and the rights and obligations of the parties hereto shall be governed by and construed in accordance with the laws of the State of New York.
