**TERMINATION AND RELEASE OF SECURITY INTERESTS  
IN INTELLECTUAL PROPERTY**

December 9, 2022

WHEREAS Keystone Consolidated Industries, Inc., a Delaware corporation (the "**Grantor**") and the other grantors identified therein, entered into that certain first lien pledge and security agreement dated December 31, 2018 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**") with GLAS AMERICAS LLC, as collateral agent (the "**Collateral Agent**");

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Security Agreement, a continuing security interest (the "**Security Interest**") in favor of the Collateral Agent, in and to certain of Grantor's intellectual property, including the intellectual property and such intellectual property applications listed in Schedule A hereto;

WHEREAS, pursuant to the Security Agreement, the Grantor executed a Trademark Security Agreement dated December 31, 2018 (as amended, supplemented or otherwise modified from time to time, the "**Trademark Security Agreement**");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 31, 2018 at Reel/Frame 6565/0902; and


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such intellectual property as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby (i) absolutely, unconditionally and irrevocably releases, terminates, cancels and forever discharges all liens and the Security Interest, waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its successors and assigns in association with the Security Interest, including those intellectual property and such intellectual property applications set forth herein on Schedule A, in each case arising under the Security Agreement or the Trademark Security Agreement (collectively, the "**Intellectual Property**") and any and all other security interests or liens that the Collateral Agent or its predecessors, successors, assigns and transferees may have in or to the Intellectual Property under the Security Agreement or the Trademark Security Agreement, and (ii) absolutely, unconditionally and irrevocably terminates the Trademark Security Agreement and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest. The Collateral Agent authorizes and requests the Director of Patents and Trademarks of the United States of America to record this Termination and Release of Security Interest in Intellectual Property and agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as the Grantor may reasonably request, at Grantor's sole cost and expense, in order to perfect, confirm or evidence such release. This Termination and Release shall be governed by and construed in accordance with the law of the State of New York. This Termination and Release shall be binding upon the Collateral Agent's representatives, successors, assigns and transferees.
