TRADEMARK RELEASE AND REASSIGNMENT

December 15, 2022

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of the date first written above, by Gladstone Business Loan, LLC, as successor-in-interest to Gladstone Capital Corporation (“Grantee”), pursuant to the Security Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement.

W I T N E S S E T H:

WHEREAS, R2i HOLDINGS, LLC, a Delaware limited liability company (“Grantor”), is a party to that certain Grant of a Security Interest – Trademarks, dated as of December 14, 2018 (the “Security Agreement”), pursuant to which Grantor granted a security interest in favor of Grantee in certain trademarks, including the trademarks set forth on Schedule I attached hereto (“Trademarks”), and Trademark Collateral (as defined below) as security for the Secured Obligations; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 17, 2018 at Reel 6514, Frame 0838.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases, discharges, terminates and cancels its security interest in, to and under the following (collectively the “Trademark Collateral”):

(a) all Trademarks and the applications and registrations thereof owned by Grantor, including, without limitation, those referred to on Schedule I hereto;

(b) the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof; and


(c) all proceeds of (a) and (b) above, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof.

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee’s right, title and interest in and to the Trademarks and the Trademark Collateral.
